Procedure:

1. Sprinkle PURABYK-R 5510 into a vortex of water and dissolve

- with very high shear
- 2. Add the glycerin 3. Combine phase C
- 4. Heat up AB and C separately to 80°C
- 5. Add C to AB while high shearing
- 6. Cool down ABC to 40°C, still high shearing
- 7. Add D to ABCD under medium shear
- 8. Fill into an appropriate container
